PART OF THE CONSTITUTION OF THE ARYAN SHIKSHAN SAMITI, RISOD
(G.S.P., ANDHRA)

Memorandum of Association

1. Name.

The name of the Society is "The Arya Shikshan Samithi, Risod,

2. Aims and objects.

The object of the Society is to establish a nucleus of modern educational institutions for promoting education at Risod and in its surroundings and to do all such things that are incidental to or conducive to attainment of the object.

3. Rules of the society.

The following rules shall come into force, from the 1st of July 1953.

Membership

1. Any person who is above the age of eighteen and who pays the annual subscription of not less than Rs. Fifteen can become a member of the Society.
2. The assistant Medical Officer, Risod shall always be an Honorary Member of the Society.
3. Every person desiring to become a member of the Society shall fill the prescribed form of membership.
4. The society's financial year would commence on the 1st April every year.
5. A member, who does not pay the subscription for two consecutive years shall automatically cease to be a member.

The general Body.

6. All members of the Society shall constitute the General Body of the Society and shall always be competent to transact business of the Society.
7. The General Body shall meet the least once a year generally in the month of April and shall carry on the following among other business.
 - a) The passing of the Annual Report of the working of Governing Body.
 - b) The passing of the next year's budget.
 - c) The passing of the accounts of the year under report.
 - d) Election of the president, the Vice President, the Secretary and the Joint Secretary and the members of the Governing body when necessary.
 - e) Laying down directive principles and policy when necessary.

8. The Secretary and his absence the Joint Secretary shall chair the meeting. The meeting of the Society shall be presided over by the president of the Society and in his absence by the Vice President and in the absence of both, by a member who is elected as president for that meeting by the member present. The meeting of the General Body shall always be held in the School Premises.

9. Quorum necessary for the meeting shall be 1/2 of the total number of the members of the Society. No quorum shall be required for an adjourned meeting.

10. For every meeting of the General Body seven days' clear notice shall be necessary.

11. Every question shall be decided by majority of the votes of the members present. In the case of the votes being equally divided the president shall have casting vote.

12. The General Body shall have power to make, modify, amend, add to and cancel the rules and regulation in a meeting and shall require twothird majority of the members enrolled.

13. The president or the Secretary may convene an extra-ordinary or emergency meeting of the Society.

14. The president, the vice President, the Secretary and the Joint Secretary in order, will be obliged to convene, within a period of fortnight from the receipt of a requisition, an extra-ordinary or emergency meeting of the Society on a requisition by 1/5 of the total member of the members of the society to consider any subject noted by the requisition.

15. At an extra-ordinary or emergency meeting no business other than the one for which the meeting is called shall transacted.

Governing Body.

16. The president, Vice President, the Secretary and the Joint Secretary elected by the General Body shall be president, Vice President, the secretary and the Joint Secretary of the Governing Body, automatically. The General Body will elect five other members to form the Governing Body of the Society. the Governing Body so elected shall remain in the office for three years and continue to function until the next Governing body is elected. The president, the Vice President, the Secretary and the Joint Secretary will be known as the "Office Bearers".

17. If any member of the Governing Body resigns or terminates his membership during the term of his office, another member will be substituted in his place by the president with the concurrence of the Governing Body.

18. No meeting or proceeding of the Governing Body shall be invalid merely by reason of the existence of one or more vacancies among its members.

19. The Secretary and in his absence the Joint Secretary shall convene the meetings of the Governing body at least once every two months and shall also put up on the agenda all matters which are necessary to be decided in the meeting.

20. The Governing Body shall have the following powers.

a) To supervise and control the work and the Management of the schools and other institutions of the Society.

b) To employ, suspend or dismiss the servants of the Society.

c) To provide for the receipts, custody and issue investment, management remittance and expenditure of moneys and funds in its hands.

d) To transfer by lease, for a period not exceeding five year or by a simple mortgage immovable property with a view to improve to improv and develop all or any portion of the society.

e) To let, or pledge, moveables if occasion so requires, and to dispose of inservicable moveables.

f) To on hire or otherwise, immovable and moveable property for the benefit of the society.

- c) To dispose of the immoveable property with the consent of the General Body, if beneficial to the society.
- d) To confirm to give promotions to, to withhold and stop promotions or to grant leave to, or punish the Servants of the society.
- e) To open or close additional sections.
- f) To grant fee concessions to deserving pupils, to stop fee concessions, expel or otherwise punish suitably students whose conduct has been found to be abjectionable.
- g) To undertake the work of building and its extension.
- h) To make, alter and cancel bylaws not in consistant with the memorandum of association affecting the institutions under its control.
- i) To undertake such other works as the occasion may require for the proper and efficient administration of the institutions.

21. At all the meetings of the Governing Body five members inclusive of the president or the Vice president and the Secretary or the Joint Secretary, Shall form a quorum.

22. Every question shall be decided by a majority of the votes of the members present, in the case of the votes being equally divided, the president shall have a casting vote.

23. Meeting of the Governing Body shall unless for special reason the president otherwise directs, be held in the School premises.

24. All meetings of the Governing Body shall be preseded over by the president and in his absence by the Vice President.

25. The meeting of the Governing Body shall be held after giving each member three days' clear notice of such meetings, but for any extra ordinary or emergency meeting of the Governing Body twenty four clear notice would be deemed sufficient.

Vesting of property.

26. All property of the Society shall vest in the Governing Body represented by the president and it shall be considered as property of the society.

27. All suits, notices and legal proceedings by or against the society shall be brought in the name of the Secretary who shall represent the Society in all such matter.

Administrative Officer.

28. The Secretary and in his absence the Joint Secretary shall subject to the control of the Governing Body be administrative officer of the Governing Body.
